### PLANNING COMMISSION RECOMMENDATIONS

On December 7, 2020 at a public meeting, the Planning Commission members voted unanimously to:

- Recommend adopting the Charles & Ryan Frey subdivision of parcel #24-8-63-4.01 with the road to be made to Township specifications before being adopted by the Township.
- Recommend holding a Conditional Use Hearing for Eric & Meghan Podgers. They would like to use their property at 605 Elk Creek Rd. for a Bed & Breakfast. It is the old Elk Creek Sportsman Club building on approx. 2 acres. Septic system has been tested by ECHD and is in good working order. Building is connected to Lake City Water supply.

Motion by L. Platz, seconded by C. McConnell to schedule and advertise the Podgers' Conditional Use hearing for Tuesday, January 25, 2021 at 3:45 p.m.

On the advice of Attorney McClure, the Frey subdivision plans were not signed by the Supervisors. There is verbiage on the map regarding the road being dedicated to the Township that needs more clarification before being signed.

Christine McClure stated that she is still working on the Ordinance changes. She has about 1 ½ pages to go. She is also working with L. Platz on the DCED LGUDA (Local Government Unit Debt Act) information for the Westgate Sewer project.

The Rastatters do not live in this house full time, therefore they cannot have a home occupation in the house, motion carried (3-0).
