No one has, so L. Platz will put it on Muncibid.

#### **NEW BUSINESS**

Motion by L. Platz, seconded by C. Brocious to approve the Daniel Edder subdivision replot as he is seeking to purchase land from David A. and Jeanne Marie Bogdan. The purchase is a 0.16 is acre parcel 2A to become an integral part of Erie County Index #24-011-053.0-011.02 located alone the west side of South Creek Road south of U.S. Route 20 in tracts 498 & 499. Ashley Porter stated that he met with Fairview to review the Birchdale project. They have to determine if there is adequate capacity after their new developments are built. No time frame was established.

There is a meeting March 13<sup>th</sup> with Pennvest regarding Uncle John's Campground. No acceptance of bids will be given at this time.

There is a pre-bid meeting on March 13<sup>th</sup> for the Miller Rd. project. 8 contractors are interested, and the bid opening is the following week.

P. Dion requested a barrier to be put up near the bluff on April 8th for the eclipse.

## **COMMENTS FROM THE STAFF**

Jeff Ferrick stated that the roadcrew is jumping between finishing winter work and beginning spring projects. CAT is replacing a bearing that broke. The equipment is still usable.

### **PUBLIC COMMENT**

Ray Penkalski asked if worn out street signs will also be replaced when the Township replaces road signs. He was told yes, that was included in the cost.

Dennis Olesnanik wanted to know who posts the reflective address signs that he's seen in other townships. He was told that we sell them along with the fire departments and some other municipalities.

Sandy Anderson stated that she has 11 sponsors for MITP and 10 weeks of music planned. She also asked about the Birchdale sewer project. How many residents were accounted for and how was that number determined? Ashley Porter explained that DEP looked at the number of current permits for the area.
