Tiffany Kramer mentioned that the outlets in the west park need looked at and possibly replaced. She also provided the zoning report for the month of August.

John Adams stated that the work on Barbara Drive was completed and that the loader will be going to Cranberry, PA to be repaired.

PUBLIC COMMENT

Ray Penkalski asked if any road paving was taking place this year. L. Platz said it would be starting Monday. He also asked if the paving was bid out, which she replied that it is.

Tom Hosack mentioned that Erie County Gaming Revenue Authority has grants currently available which may help with park projects. He also stated that because it has been so dry lately, we need to be pro-active with burn bans. The Supervisors agreed and said that the Township will cooperate with the Fire Departments opinions.
